CLASS SPECIFICATION**

<b>Position Title:</b> Street Sweeper Operator	<b>Job Family:</b> 6
<b>General Classification:</b> Front-Line	<b>Job Grade:</b> 16

**Definition:** To operate and maintain equipment used in cleaning the streets, parking lots, and alleys in an assigned area.

**Supervision Received and Exercised:** Receives general supervision from the Street Supervisor and technical supervision from the Streets Maintenance Worker III.

**Examples of Duties:** Duties may include, but are not limited to, the following:

1. Operate a motor sweeper and sweep streets, parking lots, and alleys on assigned routes; maintain route map books; select effective and efficient method to cover assigned route.
2. Clean and make minor mechanical adjustments to the motor sweeper and brooms, including replacing brooms using appropriate tools.
3. Check and refill gas, oil, air, water, and battery water in motorized equipment; clean and change filters.
4. On nonsweeping days, clean debris from storm drains and catch basins and trim trees obstructing street cleaning.
5. Assist in maintenance of equipment parts inventory; inform supervisor of needed inventory.
6. Maintain daily sweeper activity log; complete reports as directed.
7. Perform manual labor, including hand-sweeping and assisting Street Maintenance crews.
8. Train new Sweeper Operators as directed.

9. Interact with the public while performing duties, including responding to inquiries, answering questions, and referring the public to appropriate resources.
10. Perform related duties as assigned.

**Minimum Qualifications:**

Knowledge of: Principles, methods, and techniques of motor sweeping operations; standard safety precautions necessary in the work; traffic laws as they pertain to the operation of assigned equipment; service requirements of motorized street sweepers; and Mountain View street system and established sweeping routes.

Ability to: Operate a motor sweeper skillfully and safely; perform minor mechanical adjustments and maintenance to equipment; follow oral and written directions; maintain daily activity logs and records; and establish and maintain effective working relationships with those contacted in the course of work.

**Experience and Training Guidelines:** A combination of relevant education, experience, and training that satisfies the required minimum qualifications, knowledge, and abilities.

One year of experience operating heavy equipment or trucks in public works or construction operations and education equivalent to the completion of the 12th grade.

**Required Licenses or Certificates:** Possession of a valid California Class B Driver License. Possession of a California Class A Driver License is highly desirable.

**Working Conditions:** Preemployment and periodic respiratory examinations may be required for this classification.
